(Seven branches)) and willing to change the branch are also eligible to attend this round, as per inter-se-merit and <u>must fill the google form</u>. Such candidates must be present in person (Not online mode) on 12th September 2024.

Instructions to the candidates:

- It is mandatory for all the interested candidates to fill the process form (attached herewith).
 Kindly fill all details carefully, check your ICT serial number mentioned in the applied candidates list uploaded on the website and carry print out of the process form along with you on 12th September 2024 during Institute-level round.
- 2. It is mandatory for all the interested candidates to report at the Institute before 8.00 a.m. sharp on 12th September 2024.

- Only those candidates, who have filled the google form and their name appears in the applied candidates list uploaded on the website are eligible. No fresh applications will be considered under any circumstances.
- 4. Candidates are requested to bring all original documents along with Demand Draft, SC Verified set, and one self-attested photocopy of each document. Candidate will lose claim, if he/she fails to produce ALL the applicable original documents at the time of seat allotment. In case the candidate has already taken admission elsewhere he/she will be required to submit / produce original retention letter / original fee receipt and the candidate should submit undertaking stating that original documents will be submitted by him/her within four working days from the date of reporting.
- 5. The seat allotment will be carried out based on the vacancy status at that point. Seat allotted, accordingly, to the candidate would then be deleted from the pool of vacant seats displayed on the auditorium screen. Candidates are advised to be present in the auditorium and wait for their turn as per inter-se-merit. If a candidate is found unavailable when called, the next candidate in the merit list would be called for allotment of seat and the unavailable candidate may miss his/her chance of merit based seat allotment.
- 6. Even if candidate has registered and verified the documents during the round at ICT Mumbai and is not present in the KV auditorium ICT Mumbai during seat allotment OR If a candidate of higher merit reports late during the process of admission, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time.
- 7. The candidates unable to attend admission round in person should give an ORIGINAL (NOT SCANNED) authority letter in given Proforma-C (attached herewith) to his/her parents who will be attending admission round on behalf of the candidates along with ORIGINAL retention letter / original fee receipt.
- 8. All eligible candidates may attend this round. However, attending the counseling round does not guarantee the offer of a seat.

The candidate is required to pay the fees through **Demand Draft ONLY** (in favour of "**Institute of Chemical Technology, Mumbai**", payable at Mumbai). If a candidate fails to pay the requisite institute admission fee at the time of the seat allotment at that moment, such candidature will be withdrawn, and the seat will be allotted to the next candidate in the merit list.
